#### SECOND ANNOUNCEMENT OF ACCESSIONS WORKSHOPS:



#### **ACQUISITIONS:**

Another closet cleaning from Connie Sweetser! This time we acquired paperwork of the formation of the Farmers' Market, the involvement of Sweetser's Apple Barrel and Orchards in that organization, and several years of pertinent information about the Farmers' Market. We learned that there was a lot of hard work involved, meetings to attend, laws to abide by, permits to attain, approvals to get by, and just general "stuff".

Jeff Porter donated a 1985 Greely Shield (yearbook). One more to add to our collection. We are still looking for some these others: the years 1965, 1967, 1975-1977, and 1982.

Yarmouth Historical Society received a donation of items, one of which the donor suggested come to Cumberland. YHS contacted us and we received a fascinating scrapbook that George Blanchard had kept. It has numerous pages of ads, notices, announcements, and catalogues about the Broadmoor Farm, Jersey cattle, and the Blanchard Brothers agricultural supply store in Portland. What a gift!



Brian Jensen discovered this neat little item, and sent a picture of it.He did all the research and connecting the names with their families. The Gurney School is the one on Skillins Road, just east of the Cumberland County Riding Academy grounds. It sits back a little bit from the road, in the woods, so is not easily noticeable. It is now a private residence. Nice work, Brian. Notice the spelling of the name of the school.



His research discovered these little tidbits: Belva, age 6, and Stella, age 8 are the daughters of Herman & Harriet (Mountfort) Wilson. Belvah and Stella are 2<sup>nd</sup> cousins once removed of Henry, Howrd and Willis. Hazel, age 6, is the sister of Carroll and Clifford, below. Charles, age 11, and Warren, age 6 are the sons of Lorenzo and Minnie (Main?) Farwell. Leonard Flint, age 6, is the son of Leonard and Emily(?) Flint. If Minnie's last name was Main, Minnie was a nickname; her given name was America. I believe Leonard was the father of Nancy, who was in the last class at the brick schoolhouse. Harold, age 9, is the son of Charles and Elizabeth (?) Lawrence. Alton, age 9, is the son of Albert and Harriet (?) Mountfort. Philip, age 11, is the brother of Raplh, below. Ralph, age 9, is the son of Clarence and Ella (?) Prince. Carroll, age 8, and Clifford, age 10, are the sons of George N. and Carrie (Russell) Wilson. Carroll and Clifford are the 1<sup>st</sup> cousins once removed of Henry, Howard and Willis. George N. is the great grandfather of long time town worker , Brian Wilson. Henry, age 13, Howard, age 11, and Willis, age 8, are the sons of Lorenzo and Sarah (Morrison) Wilson. Sarah was the granddaughter of Ephraim, for whom Morrison's Hill is named. Henry was the last Wilson to own the mill on Skillins Road. Howard's daughter, Barbara, age 93, is the 4<sup>th</sup> cousin once removed of our own Betsy Huston (secretary of Cumberland Historical

Society). Trustee Lynda (Wilson) Jensen is the great granddaughter of Lorenzo and Sarah. She grew up in the same house as Lorenzo grew up in, and now lives in the same house that Sarah grew up in. (EDITOR"S NOTE) WHEW!!! What a lot of work went into that little school notice!

Ads in the Falmouth Forecaster are \$30.00 each. The Market signs are \$69.20 each.

We discussed if there is a farmer's market month proclamation and if there is any grant money available through the Dept. of Agriculture.

There was a discussion about press releases for the Shopping Notes and the Falmouth Forecaster.

Road signs are being placed at Drowne Rd., Rte. 100, and Skillins Rd. /Blanchard Rd., Rte. 9 and Tuttle Rd., Rte. 88, and the overpass, Rte. 1, and Tuttle Rd. Two new signs are to be placed at Tuttle Rd., and Middle Rd., and Rte.9 and Greely Rd.

There were 225 mailings sent by Cumberland Mainland and Trust to its members.

There was a motion to change the closing hours to 1:00 p.m.

New Business: Donna is looking into changing the location to the Greely Jr. High. She will be talking to Shannon Welsh, the Principal, to see if there is room available. There was a discussion about scales and if they had to be inspected and sealed.

I have heard nothing but positive reports on the Market. This is the time to start planning for next year. To that end, the end of the year meeting is scheduled for **Monday, October 28<sup>th</sup>, at 5pm,** in the Council Chambers of the Cumberland Town Office. The meeting is mandatory if you are planning to participate in the Market next year. The Town Council will be holding a meeting in the Council Chambers starting at 6pm, so we only have an hour.

To make the best use of time I am proposing the following agenda (any and all of these items are subjuct to change):

- 3. Farmers comments (2 minutes each farmer)

The other papers and meetings included discussions about bulk seed orders, establishing a logo contest, proposals for canopies, tents, awnings, etc., and moving their location to Greely High School lawn. This is what was written about that:

MSAD #51 has not only approved letting the Farmers' market use the property in front of the high school, but they encourage it. They will also make both running water and electricity available. I think this should be a welcome amenity to some of you. Whether or not the Bennet House will still be there is anyone's guess. *(It was later torn down)* I don't think it matters one way or the other if the building is there or gone. Let me know if you disagree. It is likely that the school dept. will not let you park on the grass. This means that you will have to set up tables, then move your truck to the parking lot. You should be thinking about how this will effect you, and if you can live with the condition.

Also, if the Bennett does come down, you will not be able to use the grass in the area of the house as they will be working getting this lawn established. At the meeting that we had with the school deaprtment, Sally Merrill brought up the very good option of using the area along side Osgood Drive (the opposite side of the lawn from where the Bennett House is). The idea was well received, and will be looked into further if need be.

Relocating to the front of the high school will require Site Plan Review approval the Planning Board. I am hoping to bring this to the Planning Board in February. My bringing this appliaction to the Board raises conflict of interest, and ethical issues. As reviewer of the project I should not be involved with the project. I don't think my involvement with the Farmers' Market is any secret, nor would I lead anyone to believe it is ant different than it is. I will announce for the record my involvement so that there is no misunderstanding. My purpose in bringing this up is tha I am looking for volunteer(s) to speak on behalf of the market. The meeting is scheduled for Tuesday, February 18<sup>th</sup> at 7pm.

WHAT YOU CAN BE DOING NOW: The Market needs more vendors. An ad will be in the January 9<sup>th</sup> Forecaster. So if you know of anyone that you think might be a good candidate – talk to them. I have included a 1997 application for you to use to give away. Good luck.
