LENGTH: 1,999' (.38 MILES)

WIDTH: 22'

ACCEPTANCE DATE: 1971 Art 31

Article 31: On motion of Mr. Woodbury, it was voted to accept this article as written; Maple Street; Island View Drive; Ebb Tide Drive, Section of Philip Street and a strip of land on Hedgerow Drive.

A strip of land fifty feet wide, being a right of way known as Hedgerow Drive and beginning at the southeasterly termination of that portion of Hedgerow Drive described in a deed from the Grantor herein to the Grantee herein dated January 23, 1968, said portion also being shown on Plan of Fairmeadow, Section 1 Recorded in Cumberland County Registry of Deeds, Plan Book 73, Page 16; thence running in a generally southeasterly direction approximately 1000 feet to the Val Halla Country Club right of way. Being the same premises shown as Hedgerow Drive on Plan of Fairmeadow, Section 2, recorded in said Registry of Deeds, Plan Book 76, Page 35, to which plan reference is hereby made for a more particular description.

Said acceptance to become effective only when the Selectmen and Road Commissioner determine that said road has been fully constructed in accordance with all Town requirements. Selectmen to file a report to said effect with the Town Clerk.

ADDITIONAL INFORMATION

Notice is hereby given that it is the intention of the Selectmen of the Town of Cumberland, upon the application of George Ballard and several others, all taxpayers in the Town of Cumberland, to layout and establish an additional section of Hedgerow Drive described as follows:

A strip of land fifty feet wide, being a right of way known as Hedgerow Drive and beginning at the southeasterly termination of the portion of Hedgerow Drive described in a deed from the Grantor herein to the Grantee herein dated January 23, 1968, said portion also being shown on Plan of Fairmeadow, Section 1, recorded in Cumberland County Registry of Deeds, Plan Book 73, Page 16; thence running in a generally southeasterly direction approximately 1,000 feet to the Val Halla Country Club right of way. Being the said premises shown as Hedgerow Drive on Plan of Fairmeadow, section 2, recorded in said Registry of Deeds Plan Book 76, Page 35, to which plan reference is hereby made for a more particular description.

Said acceptance to become effective only when the Selectmen and Road Commissioner determine that the said road had been fully constructed in accordance with all Town requirements.

Selectmen will meet for said purpose in Monday, June 12, 1972 in Hedgerow Drive at 6:45 P.M. and all persons interested therein will govern themselves accordingly.
