Town meeting voted to accept as a Town Way:

Karole Lane: Beginning at a granite monument on the northwesterly sideline of Main Street, and at the easterly corner of land of Floyd Brown;

WIDTH: 20'

Thence forming an included angle on said Brown Property eighty-eight degrees and thirty-five minutes (88 degrees 35') to the left from said northwesterly side line of Main Street, and on bearing north forty degrees and ten minutes west (N 40 degrees 10'W), by the southwesterly side line of said Karole Lane, a distance of six hundred and fifty (650) feet to a point and other land of said Burnell;

Thence forming an angle of 90 degrees (90 degrees) to the right a distance of forty (40) feet to the northeasterly side line of said

Karole Lane;

Thence forming an angle of ninety (90 degrees) degrees to the right a distance of fifty feet (50') by said northeasterly side line of said Karole Lane to a granite monument, and the westerly corner of a proposed street and turnaround area;

Thence at ninety (90 degrees) degrees to the left a distance of

fifty (50') feet to a point;

Thence at ninety (90 degrees) degrees to the right a distance of forty (40) feet to a point on the northwesterly side line of lot number five (5) as designated on said plan;

Thence at ninety (90 degrees) degrees to the right, by said lot number five (5) a distance of fifty (50) feet to a granite monument and the westerly corner of said lot number five (5) and the northeasterly side line of said Karole Lane;

Thence at ninety (90 degrees) to the left and on bearing south forty degrees and ten (10) minutes east (s 40 degrees 10'E) a distance of five hundred and ninety-six hundredths (560.96) feet, by the northeasterly side line of said Karole Lane to a granite monument and the said northwesterly side line of Main Street and the southerly corner of land of Dorwin Draper;

Thence forming an included angle of eighty-eight degrees and thirty five minutes (88 degrees 35') to the left, by said Main Street, a distance of forty and one hundredths (40.01) feet to point of beginning.

MARCH 5, 1966

Town Meeting Voted to Accept as a Town Way:

Karole Lane Extension:

A certain strip of land situated in the Town of Cumberland, County of Cumberland State of Maine, said strip of land being forty (40) feet in width and an extension of Karole as shown as a road on a plan entitled Section B, a portion of Kerrydale Vista, made for Carlan Burnell and recorded in Cumberland County Registry of Deeds, Plan Book 64, Page 1, being that portion of said strip extending in a straight line two-hundred and eighty-five (285) feet, more or less, to the end of Lot No. 9 on said plan, being more particularly bounded and

described as follows:

Beginning at a monument on the northeasterly side of Karole Lane, said monument being the southerly corner of Lot No. 7 of said plan;

Thence continuing Karole Lane in a straight line two-hundred and eighty-five (285) feet to a monument at the intersection of Karole Lane and Gross Street. Said description being the northeasterly boundary of a forty (40) feet strip of land as shown on the plan.
