#### I. APPROVAL OF MINUTES

Motion by Councilor Gruber, seconded by Councilor Perfetti, to accept the December 10, 2012 minutes as presented.

#### II. MANAGER'S REPORT

Police Chief Charron gave the following report re: the recent graffiti activity at the Senior Housing complex and the Middle School:

On Saturday, December 1<sup>st</sup> at approximately 10:00 p.m. an unknown number of individuals armed with at least 3 cans of spray paint, sprayed graffiti, which appeared to begin at the middle school and proceed to the senior housing complex on Hawthorn Court. Two houses on Meadow Lane were spray painted as well as a motor vehicle. The painting was discovered on Sunday morning and reported to the Police. Officer Mazuzan began an investigation and several individuals were interviewed by the Police, with their parents present. After several days, the initial suspects were cleared of any involvement. On December 6<sup>th</sup>, 7<sup>th</sup> & 8<sup>th</sup>, Officer Mazuzan, with the help of School Resource Officer Dalbec, discovered two new suspects. On December 8<sup>th</sup>, the individuals responsible for the graffiti were interviewed and have been charged with aggravated criminal mischief. Later that day, the 2 individuals responsible came to the Police Department with their parents, and were issued Juvenile Summonses. The police reports will be forwarded to the Attorney General's Office for review regarding any bias motivation. Additionally, the reports will be sent to the Juvenile Corrections Officer for the issuance of a Juvenile Petition and ultimately to the Juvenile District Attorney's Office. The Cumberland Police Department will be seeking restitution as part of the final disposition. The 2 individuals have been released to their parents, and are awaiting formal charges.

Chairman Moriarty asked Chief Charron what is the value of the restitution.

Chief Charron estimated \$2,000.00

Councilor Gruber said that it speaks volumes that Officer Dalbec was able to get the names of the two individuals responsible. He is well respected by the students.

#### IV. LEGISLATION AND POLICY

# 12 – 196 To hold a Public Hearing to consider and act on authorizing the Code Enforcement Officer to enter into a Consent Agreement with property owners located at 249 Gray Road.

Chairman Moriarty explained that these types of items come up when an owner is selling their property and a mortgage appraisal discovers a minor encroachment onto their neighbor's property. These issues can become

an impediment to a buyer when attempting to get mortgage approval, as well as not being in compliance with the Town's ordinances. The consent agreement will take care of the encroachment violation. The land owner will pay a \$500 fee to take care of attorney fees.

Motion by Councilor Perfetti, seconded by Councilor Storey-King, to authorize the Code Enforcement Officer to enter into a Consent Agreement with property owners located at 249 Gray Road and assess a \$500.00 fee for Town Attorney and Staff review.

**Chairman Moriarty** – He had an inquiry from a citizen regarding the adult swim hours at the Greely Pool. It appears that some sessions were abruptly cancelled due to lack of coverage. He wondered if the issue was being addressed by the Recreation Department.

The Manager responded that this was the first he had heard of it and would follow up with the Recreation Department.

**Councilor Gruber** – The Food Pantry is now serving 74 families, the majority being from Cumberland. He encouraged anyone in the community who is in need to please use the pantry. They are there to service those in need and confidentiality will be assured.

**Town Manager Shane** – The Food Bank has been working with Kevin Foster and firefighters for Toys for Tots. 54 children will be receiving toys this year, thanks to their help.
