As a resident, I am permitted to pick up compost for my personal use at the Town's brush dump. I have been advised that I am required to personally load the compost into my vehicle or trailer and that it shall be my exclusive obligation to evaluate my physical capabilities, personal health conditions, and preparedness prior to undertaking the loading of compost into my vehicle or trailer. However, should I voluntarily elect to have a member of Town staff load compost into my vehicle or trailer using Town equipment when available:

I acknowledge that I have assessed the potential risk(s) associated with having Town staff load compost into my vehicle or trailer, and I voluntarily and knowingly assume all liability for these and any other risks that may or may not be reasonably foreseen and that may result from or arise out of the Town staff's efforts to load compost into my vehicle or trailer. I further acknowledge that I am solely responsible for my safety at all times when in the vicinity of the heavy equipment used to load compost into my vehicle or trailer and during any such loading activities.

I hereby voluntarily and knowingly release and hold harmless the Town of Cumberland, its employees, elected officials, volunteers, agents, representatives, successors and assigns from any and all liabilities, causes of action, and/or claims of any kind, known or unknown and foreseen or unforeseen, resulting from or arising out of the loading of compost into my vehicle or trailer, including, but not limited to, claims for injuries, accidents, loss, or damage whether caused by the actions of myself, another resident, employees, elected officials, agents or representatives of the Town of Cumberland, or another third party. I further waive the right to hold the Town of Cumberland, its employees, elected officials, volunteers, agents, representatives, successors, and assigns, liable for any direct, indirect, special, incidental or consequential damages for any use or non-use of, or reliance on the loading of compost by Town staff into my vehicle or trailer.

I UNDERSTAND THAT THIS PASS IS FOR MATERIALS GENERATED FROM A CUMBERLAND PROPERTY ONLY AND THAT SHARING THE USE OF THIS PASS WITH OTHER PROPERTYS SHALL BE CAUSE FOR REVOCATION OF THIS PASS WITH NO REFUND. **PASS MUST BE DISPLAYED IN FRONT WINDSHIELD OF VEHICLE AT TIME OF USE.**
