

I. Call to Order

The meeting was called to order by Chairman, David Witherill at 6:00 p.m.

II. Adopt the November 28, 2018 Minutes

Chairman Witherill inquired if there were any changes or additions to the Minutes. There were none.

III. Harbormaster Report

Harbormaster Merriman was in attendance. He stated that Colleen Frank of Summit Point Seafood has filed an aquaculture application with the Town of Falmouth for a 100-acre seaweed aquiculture. It will be 7 feet below the surface and it will only be in during the winter months. All the equipment will be removed during the summer months. She meets all 10 criteria points. The farm is located between Clapboard and Upper Clapboard Islands. The majority of the aquaculture will be in Falmouth and only 3% of it will be in the Town of Cumberland.

IV. 2019 BCR Mooring Allocations

A discussion took place regarding what the number of BCR mooring allocations should be for 2019. The commission wanted no more than 25 and the Harbormasters would like to see approximately 50 along with a wait list. With the use of Online Mooring Services, it shows that currently there are 5 approved, 2 are under review and 25 incomplete applications in the system for BCR. Even though in the past we have had approximately 20 approved moorings, we only had approximately 5 boats actually moored in BCR. David Witherill had concerns as to how many dinghies would safely fit on the floats. With the new pier, it is unknown how many people will actually use the BCR moorings in 2019. A question came up as to whether the Town is required to maintain a wait list. After checking with the Town Attorneys, it was determined that State law states that we do need to maintain a wait list.

After a lengthy discussion, it was determined that we should increase it from 25 to 35 moorings in BCR with a wait list and reassess either during or after the 2019 season. It was suggested to amend the ordinance to require the mooring holder have a mooring **scheduled** to be installed by a mooring installer by June 1 and **installed** no later than July 1, or forfeit your right place a mooring in BCR and forfeit your payment and be subject to reinstatement fees.

It was noted that the commission approved 25 BCR 2019 Mooring Allocations at the November 28th meeting. Should

the commission want to amend this, we would need a reconsideration motion.

- Permit Year Definition
- Dockage Time Limit
- Moorings 48-8.3(a) and (c) Assignment and Location of Moorings
- Kayak / Paddle Board Storage

After reviewing and discussing all the proposed changes, the commission decided to approve the changes.

VI. Kayak Rack

David Witherill stated we needed to determine the number kayaks that will fit on the racks on land and on the float. Bill Shane advised he thought we may have around 24-36 spots available. The Town has ordered 40 kayak registration stickers. The rental fee is \$50.00 per application. The commission reviewed the proposed 2019 Kayak/Paddle Board Storage Rack Rental Application. After discussion and some minor grammatical changes, it was agreed to by the commission.
