## TERMS OF AGREEMENT

1. Renter must be a resident of the Town of Cumberland.
2. Each storage rack unit may be used only for the two personal watercraft listed above. Storing unregistered personal watercraft is a violation of Town of Cumberland ordinance.
3. Cost for each personal watercraft is \$50.
4. Rack rental will be selected by lottery. Applications must be received by the Town Clerk's Office by the last Thursday in March. A lottery will be held on the first Thursday in April.
5. If selected, renter must pay the \$50 rental fee for each personal watercraft to be stored prior to the start of storage. Renter will receive sticker(s) to affix along the port side of personal watercraft. A renter who does not pay the fee within thirty (30) days of notice will forfeit the storage space, and the space will be awarded to the next renter on the list.
6. Renter agrees to remove personal watercraft by October 1. Failure to timely remove personal watercraft from rack by date stated will result in the inability to rent during the next year.
7. Renter must ensure the personal watercraft is reasonably secured and locked in its assigned rack space and will not pose a risk to others. Owner must provide locking mechanism.
8. Renter must ensure the rack space is always clean and tidy. Nothing other than two registered personal watercraft can be stored in the rack at any time.
9. Renter acknowledges that storage rack rental is at their own risk. The Town of Cumberland accepts no responsibility for loss of or damages to personal watercraft.

I agree to abide by the rules and regulations stated above and I hold myself solely responsible for any mishap/injury or damage to the personal watercraft listed above. Failure to comply with above terms will result in termination of this agreement with no refund of rental fees.
