From: Ellen Hoffman Re: Meeting October 4, 2023

- O September minutes were approved as written. John moved to accept; Riva seconded.
- O Jesse Lamarre-Vincent chair of the Orchard Subcommittee was added to a member of the Commission.
- O Town Council report (Tig and Mark)
 - Forest Subcommittee will host a walk in the Town Forest with Town Council. Date changed to November 4, 7:30 AM.
 - Joint board meeting with MSAD51, Cumberland and North Yarmouth Oct 25 6-8 PM Westcustogo Hall – discuss new school.
 - New trash contractor (Mark)
 - Casella maybe start July 1st
 - 5 yr. contract
 - No longer pay/bag but will not have bulky item pickup idea of large containers
 - Details need to be worked out
 - Question (Riva) since one large recycle container, does this limit how much can be recycled?

TOWN LANDS AND CONSERVATION COMMISSION (Commission)

- Question (John) will there be an option for smaller containers for those who need to bring trash/recycle out to a long driveway?
- Skyview Dr Rt 1 (Mark) Property was owned by Peter Kennedy and was recently bought by Mike Foley who owns Foley's Fitness Center in Scarborough. Zoned commercial. Possible fitness center project needs to clear Planning Board. Riva asked, if possible, to make a continuous trail along Route 1 from The Mark to senior housing. Mark said need landowner approval. Route 1 would need to be expanded for walking path parts too narrow. John said they would look into it.
- Mowing grasslands (Mark) meeting with Mark, Bill S, Gordon, Mike and Tig, to discuss proposed language regarding the protection of birdlife in both Twin Brook and on Stiles Way. Following meeting, Mike and Gordon will propose updated language as to the requested town mowing schedule for those two parcels.

O Bill Report (Bill L's handout)

- During the month of September 2023, Bill's office issued 21 permits for new buildings such as for pools, sheds, decks, houses, condos, barns, additions, renovations, commercial and solar installations.
- Approved projects under construction:
 - Oceanview phase 2- 11/52 permits have been issued
 - Christmas Creek Vining Way 19 of 20 are completed
 - Orchard Road Cortland Court 8 of 10 building permits issued as of this date
 - Snowy Owl off Old Gray Road –10 units approved; still blasting
 - The Mark off Route One—45 units approved; site work blasting complete
 - Ross Estates off Blanchard Road Ext.-3 Units approved; pre-con complete
 - Yarmouth Vet at Heritage Village pre-con complete. Blasting permit issued;
 work has started blasting usually two to three times a day
 - White Rock off Skyview Drive 55 units of senior housing awaiting MSHA
 - Lot split of existing subdivision by amendment at 104 Foreside Road
 - LGC Solar Field as approved in May with conditions; now under construction
- Planning Board meeting scheduled for October 17, 2023 at 7pm:
 - MSAD51 amendment for Site Plan adjustments for portable classrooms (as-built)
- Future Planning Board items:
 - Public Hearing for sketch plan for 72 units (36 will be "affordable") in Chase Pit at 77 Blackstrap Road with public water from the Portland Water District extended from the West Cumberland Fire Station.
 - Rusty Lantern- Food Mart and new bank at Gray Road
 - Town antenna and carrier cell towers off Range Way and the Gray Rd.

- The Town Council has voted to seek a "Request for Proposal" at the area of the Little League fields adjacent to the old Drowne Rd School for new housing proposed to be mixed use family and senior housing. If a proposal is submitted, the LCC will need to make a recommendation to the Town Council for use of Town property.
- Relocation of the Little League fields to a new location such as off Stiles Way or another location. The relocation will also require a LCC recommendation to the Council.

Late Summer 2023 Newsletter

MEACC's Annual Conference will be on October 21, Saturday 9AM

Keynote speaker Eamonn Hutton from Viewshed Consultants was the principal author of a recently completed, outstanding Bridgton Open Space Plan. Eamonn will discuss how the plan was prepared and how it sets forth a vision for the Town's open space resources with a focus on resilience, connectivity and activation. The plan was fully funded with a grant from the State's Community Resilience Partnership Program.

Presentation 2 will concern **how to enroll in the Community Resilience Partnership Program.** The program's enrollment steps, Bridgton's experience enrolling, and Manchester Conservation Commission's recent beginning with the enrollment process will be discussed by Fred Snow who has worked as a community planner and is president of MEACC.

Conservation Commission Share Time. Each attending conservation commission will share through a spokesperson what and how they've been doing and any concerns or lessons learned. Attendees of past annual conferences have found "share time" invaluable.

Networking Lunch We will be offering lunch along with an opportunity to network with other conservation commissioners.

Location: The conference will be in the Morrell Meeting Rm at Curtis Memorial Library in Brunswick. located at 23 Pleasant St., which is on the corner of Pleasant St. and Middle St.. After passing the front of the library take an immediate right on Middle St.. The entrance to the Morrell Meeting Room fronts Middle St..

- Apparel Impact box in Town Hall parking lot. Box seems to be getting a lot of use. Time for a second box?
- Trails Subcommittee (John) Trails have been drying out and hopefully work will begin on them soon.
 - John and Brian Stearns met with Bob Abbott of North Yarmouth to discuss a new walkway in the North Yarmouth side of Knight's Pond. John and Brian agreed to provide assistance with the effort. John did some trimming of the buckthorn in one of the viewing areas along the White Trail in Knight's Pond. John and Gordon had done some preliminary work in that area last year.
 - Trails Subcommittee is still awaiting information from Sevee Maher Engineers concerning efforts to improve the Red Trail in the Godsoe portion of Rines Forest. John and Brian met with CCLT concerning needed improvements to the Waterfalls Trail. John and Chris will coordinate this fall to see if the trail is sufficiently dry to get gravel in to the area near the third bridge.
 - Windham Trail (Denny) Maine was awarded more than \$1 million in federal grants for new conservation and outdoor recreation projects. About half of that money was awarded to Windham to buy 697 acres of heavily forested land and build a 1.3-mile universal access trail close to Falmouth.
- o Forestry Subcommittee (Gordon):
 - Admin Need to draft grassland management section for website.
 - Grassland Management meeting to discuss policy language (see above Commission)
 - Town Council Walk new date see about (Council)
 - Invasive
 - Spraying finished for 2023, grinding continues
 - Ian, Town employee from Val Halla, has been very helpful and enthusiastic
 - Do we look into budgeting for an external company to supplement PW and cover more ground next year?
 - Go-forward plan grind and follow the grinder with spraying
 - Paul is working on master list of all areas in need of treatment in priority order
 - Edges of fields at Twin Brook could be a good candidate for grinding and spraying; may be able to grind the areas this winter.
 - Town Forest more grinding happening now; to be sprayed next year. Spraying of previously ground areas was completed using a weaker solution than used by the contracted company after review of their formula. Mike spoke with a lady who contacted him over concerns of the spraying in the Town Forest.
 - Twin Brook Area 1 was both sprayed and stem treated after Paul marked it

- Signage Town Forest signs have been installed
- Management Plans and Forest Management Plans
 - Town Forest There was a forest management plan created around 10 years ago that needs to be updated. Gordon to add updating the forest management plan to 2024 Forestry To-Do list.
 - Greely Woods Per the easement with CCLT, we need to create a Management Plan and a Forest Management Plan. Gordon to add creation of both plans to the 2024 Forestry To-Do list.
- Sustainability Subcommittee (Denny)
 - Cumberland was not awarded any CRP (Community Resilience Partnership) money this go round since we have previously been awarded money.
 - Denny noted that the Greely High School students are actively seeking ways to divert school food waste away from the landfill. Prior to the pandemic, the school was practicing single sort recycling and a vendor was picking up the food waste for composting. With roughly 2,100 kids, a lot of waste is generated daily which currently goes directly into the landfill. The Town composting facility uses horse manure from the fairgrounds and yard waste from residents. The resulting compost is ideal for landscaping and vegetable gardens. The facility is looking into adding the capability of accepting food waste from residents. This would be an ideal solution for diverting MSAD51 food waste. Issues such as storage, transport and rodents would need to be addressed. Possible pilot project. The Sustainability Subcommittee will provide whatever assistance is necessary to facility this project.
 - Denny mentioned the next (new) school project what are the sustainability features? Difference between net 0 and zero carbon. Zero carbon is the goal set in the CAP low carbon, carbon sequestration. The definition of net 0 and zero carbon depend on the context.
- Community Orchard (Jesse)
 - Jesse is working on getting new members instated
 - The initial 90 trees purchased from Fedco Seeds is set for a spring delivery; along with some rootstocks/scions to run a grafting class in the spring.
 - Jack (Iveson) potential new member has made initial contact with the folks at all MSAD51 schools with the idea to get the kids helping with the seed planting and getting them involved in the orchard, either as field trips for the elementary school kids, or as community service projects for the older ones.
 - Mike and Jesse purchased a 12*16 shed from Hill View Minibarns to be delivered Nov 3 to the Stiles Way site. The Town will have to put in a crushed rock pad for the shed to be placed on. The shed will be locked.

- Hand tools will be purchased from AM Leonard; an order is being put together.
- Chris will get the field flail mowed and put posts to mark the edges of the allowed planting area (agreed upon setback from the compost pad). The Orchard Subcommittee will do a site assessment and pull strings to mark out the approximate placement of the initial orchard rows once Chris's work is complete. Also need to mark off the wet areas.
- Lawns Gone Wild the last Lawns Gone Wild educational seminar will be on site at Stiles Way October 28th at 10am. The seminar will be run by the Wild Seed Project on native seed sowing. Having the seminar on site will give some visibility for the orchard to the community. Some of the seed pots will be set aside for spring planting.
- Invasives Subcommittee (Mike)
 - Dave Cowan is interested in chairing an invasive subcommittee.
 - Riva remarked that the LCC should occasionally revisit our priority of subcommittee structure.
 - Dave C has contacted Amanda Devine, Associate Director of Stewardship with the Maine Coast Heritage Trust, to give a presentation at Val Halla November 2, from 7-9 on invasive plants.
 - Mike mentioned that besides the work being done in our forests and parks, we need to look at roadsides. Some areas have been sprayed once but no sufficient follow-up spraying.
 - Outreach to community to explain what and why we are doing regarding invasive plants.
- New Business/coming attractions (Mike)
 - Future for composting no update
 - Tree City designation no update
 - New Member documentation no update
