## TODAY'S CONSTRUCTION ACTIVITIES

McGoldrick resumed drilling & blasting along 200 LF of water main extension from STA 21+00 (41 Middle Road driveway) to STA 19+00 (Waterfall Way). Overburden generally 3 feet.

Storey Brothers resumed installation of 6-inch underdrain on the west side of the road from yesterday's endpoint at STA 44+30 southerly 240 LF to the outlet at the existing 18-inch culvert at 41+88.

Storey Bros. then resumed box cut of road from yesterday's endpoint at STA 46+00 southerly 260 LF to STA 43+40.

Construction Services & Irrigation performed third flush on the main and re-sampled hydrants of water main extension.
