TODAY'S CONSTRUCTION ACTIVITIES

McGoldrick resumed drilling & blasting along 150 LF of water main extension from STA 17+25 (just north of culvert) to STA 15+75 (just south of northern driveway for 31 Middle). Overburden ranged from 4.5 to 6 feet.

Storey Brothers resumed installation of 6-inch underdrain on the west side of the road from yesterday's endpoint (driveway at 80 Middle) at STA 39+70 southerly 220 LF to STA 37+50.

Storey Bros. then resumed box cut of road from yesterday's endpoint at STA 40+15 southerly 115 LF to STA 39+00.

Summit completed testing and connection of gas main at Tuttle Road intersection.

TOMORROW'S ANTICIPATED CONSTRUCTION ACTIVITIES

Resume 6-inch underdrain southward from outlet STA 38+05 and box cut southward from STA 39+00 Continue blasting for water main extension southward from STA 15+75 and services.
