CONSTRUCTION ACTIVITIES

Installed Phase 1A portion of the connection plan from the west side of vault installed the previous day.

Transitioned from Phase 1A to Phase 2 portion of connection plan

Ledge removal needed west of sewer line crossing in Phase 2 portion

While working near the existing sewer line, the crew had to do extensive dewatering due to water entering the excavation via the sewer main trench from a failed temporary water main from the adjacent Tuttle Road project. To treat dewatering water the crew excavated a sump for the submersible pump and backfilled with crushed stone (see photo).

Completed installation of the blow-off valve in the Tuttle Road completed the Phase 2 portion of the connection plan at 6PM.

Water main connection work to resume Monday. Water service renewals south of temporary water planned for Tuesday through Friday of next week.
