

HILLSIDE AVENUE

LENGTH: 2,746' (.52 MILES)

WIDTH: 21'

NOTE: Road also known as Baptist Meeting House Road, Baptist Road)

MARCH 19, 1795

Warrant, 3rd Article: Request of Samuel Baker and others relative to opening a road from the school house above Mr. Martin's to Mr. Ebenezer Corless' and to meet the Forge Road so called or as near there at as may appear convenient, and act thereon as the town shall then think proper.

APRIL 6, 1795

Town Meeting voted to dismiss the 3rd Article.

APRIL 11, 1797

Warrant, 6th Article: To hear Selectmen's report of road laid out from or near the Baptist Meeting House to the western part of the town.

UNDATED

Return of a road from New Gloucester to the west division of hundred acre lots - beginning by the County Road to New Gloucester, two rods from the Northerly corner of the dwelling house of Mr. Grace, and in the line of the Meeting House Privilege, then in said line South 36 1/2 degrees west and the same course to the line between land of the Heirs of Edward Russell, Esqr. deceased, and Oliver Byram, and in that line until it comes within about 25 rods of the Range Way, and from thence to the line between land of Samuel Baker and Ebenezer Corless, and in that line until it comes within about 25 rods of the Northerly corner of Lot No. 3.

The aforesaid lines are all in the middle of said Road; the following are on the Northwesterly side of it, which is to be four rods wide. And from thence to the Northwesterly side line of said Lot No. 3 and on that line to the road between the Hundred and twenty acre division.

And we report, that the owners of land taken for said Road, have liberty to take all the trees on their land, so taken, at any time within four years from this date.

MARCH 19, 1798

Town Meeting voted to accept the report of the Selectmen of a road by them laid out from New Gloucester Road to Greelys Road, so called.

MARCH 4, 1924

Town Meeting Voted to raise \$300. to build over culvert on Baptist Meeting House Road.

FEBRUARY 28, 1927

Warrant, 40th Article: To see if the town will spend one thousand dollars of the highway money on the Greely Road and Baptist Road which runs from it.

MARCH 8, 1927

Town Meeting Voted to spend \$1000. on Greely Road and on Baptist

Road which runs from it.
