WOODSIDE DRIVE

March 3. 1962

Town Meeting Voted to accept a portion of Woodside Drive as a public road, described as follows:

A certain lot, or parcel, of land situated in said Cumberland, bounded and described as follows:

Beginning at a point of the northeasterly sideline of Woodside Drive at the southeasterly terminus of Woodside Drive as accepted by the Town of Cumberland, March 4, 1960; thence southeasterly on a prolongation of the said northeasterly sideline of Woodside Drive, a distance of three hundred fifty-eight and eighty hundredths (358.80) feet to a point; thence southwesterly at right angles to the last described course, a distance of forty (40) feet to a point; thence northwesterly at right angles to the last described course, a distance of three hundred fifty-eight and eight tenths (358.8) feet to a point; thence northeasterly at right angles to the last described course, a distance of forty (40) feet to the point of beginning. Meaning and intending, hereby, to convey a parcel of land forty (40) feet wide and to be known as Woodside Drive, as delineated on the aforesaid plan recorded in Cumberland County Registry of Deeds in Plan Book 55, Page 17.

March 2, 1963

Town Meeting Voted to accept an extension of Woodside Drive as a public road, bounded and described as follows:

Beginning at a stone monument at the southeasterly sideline of Main Street, said monument being distant two hundred thirty-five and thirty-nine hundredths (235.39) feet southwesterly from the stone monument at the southwest corner of Main Street and Hillcrest Drive; thence southeasterly and making an included angle of 90°06' with the northeasterly direction of Main Street, a distance of eight hundred fifty-six and fifty-seven hundredths (856.57) feet to a point of curvature; thence along a curve to the northeast, having a radius of twenty-five (25) feet, a distance of thirty-nine and twenty-seven hundredths (39.27) feet to a point of tangent, at the northwesterly sideline of Carol Street, as laid out and accepted by the Town of Cumberland, June 27, 1960;

thence southwesterly along the northwesterly sideline of Carol Street, produced across Woodside Drive, a distance of sixty-five (65) feet to the southwesterly sideline of Woodside Drive; thence northwesterly at right angles to Carol Street, a distance of eight hundred eight-one and five tenths (881.5) feet, more or less, to the southeasterly sideline of Main Street; thence northeasterly along the southeasterly sideline of Main Street, a distance of forty (40) feet, to the monument at the point of beginning. Said street to be forty (40) feet wide and to lie entirely within the limits of the above described lines, and to be known as Woodside Drive, as delineated on a Plan of lots in Woodside Acres, Cumberland Center, Maine, owned by Stanley N. Brown, dated May, 1962, and recorded in Cumberland County Registry of Deeds in Plan Book 60, Page 68.

Town Meeting also Voted to accept: 1962

An extension of Woodside Drive, bounded and described as follows:

Beginning on the northeasterly sideline of Woodside Drive at the southeasterly terminus of Woodside Drive as laid out and accepted by the Town of Cumberland on March 3, 1962; thence southeasterly in a prolongation of the northeasterly sideline of Woodside Drive, a distance of three hundred fifty-eight (358) feet to a point; thence southwesterly at right angles to the last described course, a distance of forty (40) feet to a point; thence northwesterly at right angles to the last described course, a distance of three hundred fiftyeight (358) feet to a point at the end of Woodside Drive, as laid out and accepted by the Town of Cumberland, March 3, 1962; thence northeasterly at right angles to the last described course, a distance of forty (40) feet to the point of beginning. Said street to be forty (40) feet wide and to lie entirely within the limit of the above described lines and to known as Woodside Drive, as delineated on a Plan of Silas Baker Property owned by Stanley N. Brown, Section B, dated October 24, 1961, and recorded in said Registry of Deeds in Plan Book 60, Page 21.

Town Meeting Voted to accept, "subject to final approval of Selectmen,"

A parcel of land on Woodside Drive, not previously accepted by the Town as delineated on plan made for Stanley N. Brown entitled "Section C-Silas Baker Property" dated June, 1966 and recorded in Cumberland County Registry of Deeds in Plan Book 72, Page 17.
