II. APPROVAL OF MINUTES

Motion by Councilor Bingham, seconded by Councilor Edes, to accept the April 13, 2015 meeting minutes as presented.

IV. PUBLIC DISCUSSION

Dudley Greely of Mill Road said that he came before the Council a year ago to request that the Town review its noise or public nuisance ordinances, and figure out a way to bring relative peace back to our community. Mr. Greely referred to a map showing the sites of approximately 5 dozen noise disturbance reports since 2012. He noted that home businesses are prohibited from causing any objectionable or unreasonable noise, vibration, smoke, heat, dust, electrical disturbances, heat, glare or odors that are detectable beyond the property line. If someone does not have a home business permit, they are allowed to make a ruckus and the Town cannot say anything about it. While he encourages people's free use of their own property, when the consequence of those activities goes beyond the property line, so does their unquestioned ability to engage in that activity. His complaint is hearing very unpleasant, persistent, highly repeated noises. Thousands of repetitions that he is told it is coming in from outside of the Town. He feels that the noise complaints in this Town deserve respectful and considerate response from this Council.

Councilor Edes asked Police Chief Charron how many complaints there were on Mill Road (according to the map that Mr. Greely referred to)?

Police Chief Charron responded that there were 4.

Councilor Stiles asked the Police Chief how many of the complaints were during hunting season.

Chief Charron responded that there were not dates on the report for him to determine that.

Councilor Storey-King said that the Council has discussed the noise ordinance in the past and felt that it falls under disorderly conduct. She said that she appreciates Mr. Greely's efforts, but is personally uncomfortable creating another ordinance that affects people's rights to discharge firearms. Firearms are part of our history and part of our Constitution.

Mr. Greely said that he never mentioned that the noise was from guns.

Councilor Copp said that he lives ½ mile from Mr. Greely and he has purposely spent time in his yard listening. He occasionally hears shots from the Falmouth Rod and Gun Club, but to him it is not annoying because it is far away and not very loud. He listened to his neighbor cut wood on a Sunday morning for 3 hours. It did not bother him. If we had a noise ordinance, that neighbor would be in violation for cutting wood to heat his home. Mr. Greely is the only one complaining. None of his neighbors are here to complain.

Councilor Turner said that he has lived in this Town for 35 years. He was on the Board of Appeals for over 20 years, and dealt with the 70 decibel noise limit a number of times over those years. It usually had to do with daycare centers and the noise of the children playing outside. The problem is enforcement and being able to define the actual decibel level and where it is coming from. If we had a general sound ordinance, he does not see how it could be enforced. Are we going to have the Police Department running around Town trying to figure out where the sound is coming from? We would be opening a Pandora's Box. There is nobody else complaining about what Mr. Greely is hearing. He said he is not interested in creating another ordinance, especially one that is not enforceable.


Councilor Edes agreed. He has no interest in creating a noise ordinance.


